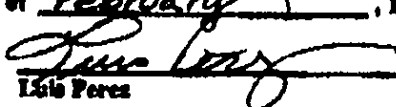
ARTICLE VIII - POWERS

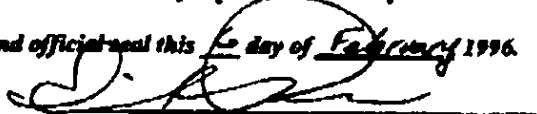

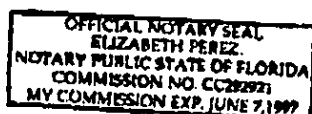
