4. The text of the amendment as adopted is as follows:

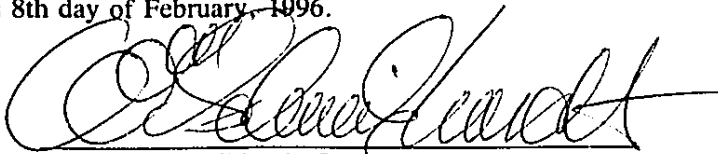
ARTICLE I is hereby amended to read as follows:

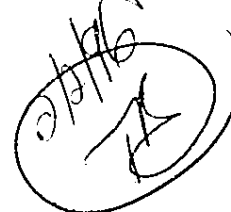

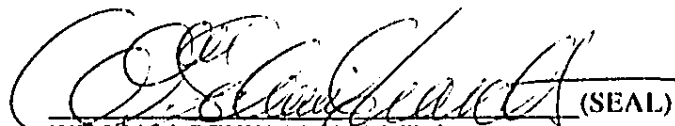
