The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates herself to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is QUICK-FIX WINDSHIELD REPAIR, INC.

ARTICLE II - LOCATION

The principal office of this corporation is to be located at 4555 N.W. 103rd Avenue, County of Broward, Sunrise, Florida 33351.
