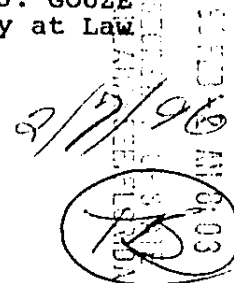

The name of the corporation is SOAP 'N SUDS CAR WASH &

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on


**ARTICLE VIII - DIRECTOR QUORUM**



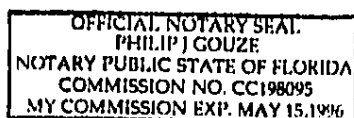
