
**ARTICLE XII



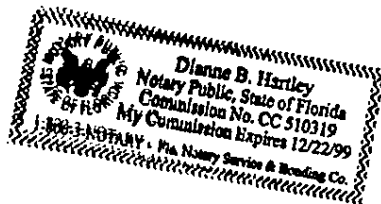


