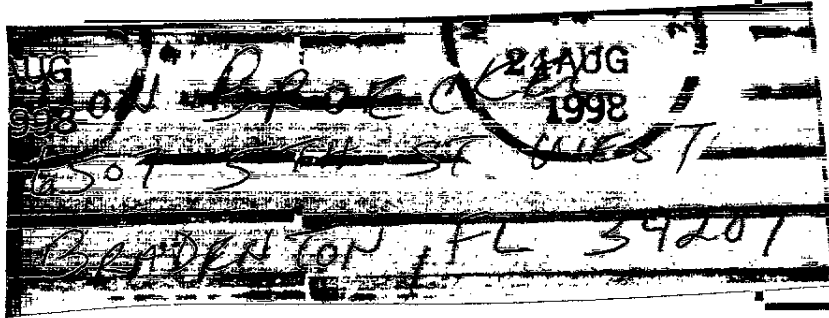

RESTATED ARTICLES OF INCORPORATION

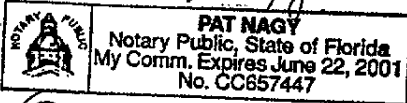

The following is a restated Articles of Incorporation for Take Aim Inc., originally incorporated on January 31, 1996. These restated Articles of Incorporation were duly adopted by the directors and approved by the Shareholders on July 24, 1998; they only restate and integrate and do not further amend the provisions of the corporation's Articles of Incorporation as theretofore amended. There is no discrepancy between the corporation's Articles of Incorporation as theretofore amended and the provisions of the restated Articles of Incorporation other than the omission of matters of historical interest.

RESTATED ARTICLES OF INCORPORATION

OF

TAKE AIM, INC.

ARTICLE I - NAME

The name of the corporation shall be TAKE AIM, INC., a Florida Corporation.

ARTICLE II - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III - POWERS

This Corporation shall have all of the powers enumerated in the 'Florida General Corporation Act', (chapter 607, Florida statutes).

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of voting common stock (one thousand shares) with a par value of \$1.00 per share.

ARTICLE V - PREEMPTIVE RIGHTS

The holders of the common stock of the Corporation shall have the preemptive right to purchase upon such price, terms and conditions as shall be affixed by the Board of Directors, such of the shares of the common stock of the Corporation as may be issued from time to time over and above the issue of the first 100 shares of the common stock of the Corporation which have never previously been sold or issued. Such preemptive right shall apply to such shares whether such additional shares constitute a part of the shares presently or subsequently authorized or constitute shares held in the treasury of the Corporation and shall be exercised in the respective ratio with the number of shares held by each stockholder at the time of such issue bears to the total number of shares outstanding in the name of all stockholder at such time.

ARTICLE VI - REGISTERED OFFICE AND AGENT

ARTICLE VII - BOARD OF DIRECTORS

This Corporation shall have two directors. The number of Directors may be either increased or decreased from time to time by the Bylaws, but shall never be less than one. The names of the directors of this Corporation are:

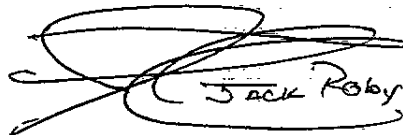
