NAME

The name of the Corporation is **SOUTHEAST DIVING ENTERPRISES, INC.**

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III

PURPOSE

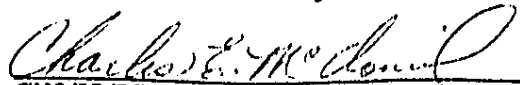
ARTICLE X

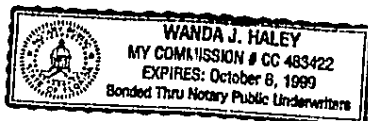

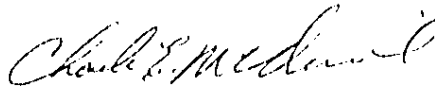

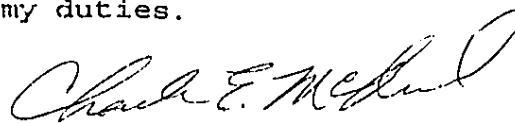
