I, the undersigned, hereby submit and file these Articles of Incorporation for the purposes of establishing a corporation for profit under the "Florida Corporation Act".

I.

II.

This corporation will engage in the business of retail sales of books, novelty items, etc. for individuals, partnerships, and corporations permitted under the laws of the State of Florida and the United States of America.

III.
