The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

**ARTICLE I  
NAME AND ADDRESS OF THE CORPORATION**

The name of the corporation shall be Dedesma-Rosefield Ventures, Inc. (the "Corporation"). The initial address of the Corporation shall be 4170 S.W. 74th Court, Miami, Florida 33155.

**ARTICLE II  
NATURE OF BUSINESS**

The general nature of the business and activities to be transacted and carried on by the Corporation is to transact all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, as hereafter amended and supplemented, and any successor statute thereto, as thereafter amended and supplemented.

**ARTICLE III  
STOCK**

The authorized capital stock of the Corporation shall consist of 10,000 shares of Common Stock, par value \$.01 per share.

These Articles of Incorporation may be amended upon recommendation of the Board of Directors approved by all its members and by vote of the holders of record of at least a majority of the shares of stock of the Corporation, issued and outstanding and entitled to vote.

**ARTICLE IX  
FINANCIAL INFORMATION**

The Corporation shall not be required to file a balance sheet and a profit and loss statement in its registered office.

This provision shall be deemed to have been ratified by the shareholders each fiscal year hereafter unless a resolution to the contrary has been adopted by the shareholders not later than four (4) months after the close of such year.
