Article I. Corporate Name and Initial Corporate Address

The name of this corporation is **SEDAP, Inc.**, and the initial corporate address is 520 Beckrich Road, Panama City Beach, Florida 32407.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III. Capital Stock

The total number of shares of capital stock which the corporation shall have the authority to issue is as follows:

- (a) One Hundred (100) shares of voting common stock having a par value of \$5.00 per share.
- (b) One Hundred (100) shares of non-voting common stock having a par value of \$5.00 per share.

Article IV. Term of Existence

This corporation shall have perpetual existence commencing upon filing of the articles.

Article V. Registered Agent and Initial Registered Office
