ARTICLES OF INCORPORATION  
OF

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this Corporation is: SO. FLA. CROSS CUT, INC.

ARTICLE II - PRINCIPAL OFFICE/MAILING ADDRESS

The principal Office of this corporation is 12230 S.W. 28th Street, Miami, Florida 33175. The mailing address of the corporation is 12230 S.W. 28th Street, Miami, Florida 33175.

ARTICLE III - AUTHORIZED SHARES

The number of shares the corporation is authorized to issue is (100) shares of Common Stock at One Dollar (\$1.00) Par Value per share.

ARTICLE IV - DURATION

The period of duration of this Corporation is perpetual.

ARTICLE V - PURPOSE

The purpose of this Corporation is:

- A. To engage in any activities or business permitted under the Laws of the United States and Florida with particular emphasis in the area of Tree Cutting and Maintenance.
- B. To do everything necessary, proper, advisable or convenient for the accomplishment of the above said purposes; and to do all other things incidental to said purpose or purposes or connected with them that are not forbidden by the Florida Corporation Laws or by any other Laws or by these Articles of Incorporation, and to carry out the said purposes in any State, Territory, District or Possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the Law of the State, Territory, District or Possession of the United States or by the foreign country.

This Corporation shall have One (1) Director initially. The number of Directors may be increased or diminished from time to time by the Bylaws but shall never be less than one (1). The name and address of the initial Director is:

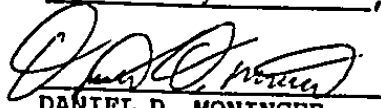

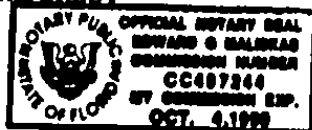
