ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be GLEN HENDRIX PAINTING & PRESSURE CLEANING, INCORPORATED, A Florida Corporation. The principal office of the corporation is 1421 Mandel Road, Fort Myers, Florida 33919; the mailing address of the corporation is 1421 Mandel Road, Fort Myers, Florida 33919.

ARTICLE II - TERM OF EXISTENCE

This corporation is to have perpetual existence.

ARTICLE III - PURPOSE

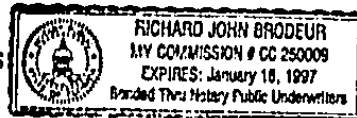

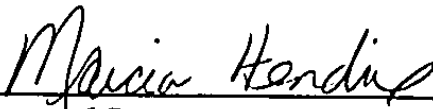

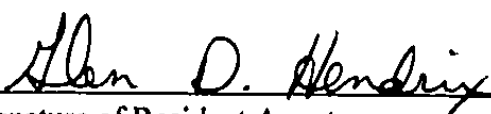
