


ARTICLE VIII

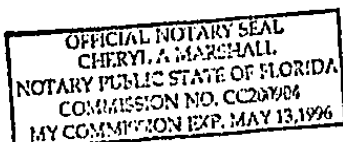


