ARTICLE ONE

NAME

The name and principal address of the corporation is

DURATION

The term of existence of the corporation is perpetual.

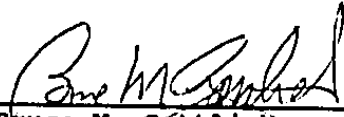

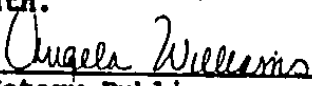
