ARTICLES OF INCORPORATION
OF

ARTICLE I – NAME

The name of this corporation is R & R DREAMS, INC.

ARTICLE II – PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

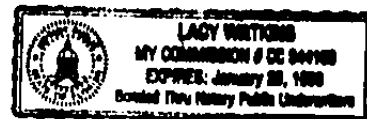
