ARTICLES OF INCORPORATION

96 FED -5 FII 1: 07

The Undersigned acting—as incorporator of this corporation pursuant to Chapter 607 of the This Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida Statutes of Incorporation for such corporation.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be Shopping Networks, Inc.

ARTICLE II - TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III - GENERAL PURPOSE

The general purpose for which this corporation is organized shall be:

- To manufacture, construct, purchase or otherwise acquire and to own, mortgage, piedge, sell, assign, transfer, or otherwise dispose of, and to invest in trade in, deal in and, with products, goods, wares, merchanside, real and personal property and services of every kind, class and description.
 - 2. To operate a broadcast network system for purchase and disbribution of products for sale.
- 3. It is intended that this corporation is organized for and may conduct and transact any or all lawful business authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended.
