I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The Name of this corporation is Lanzarote Painting, Inc., and the initial address of this corporation shall be 2540A S.W. 11th Street, Miami, Florida 33135.

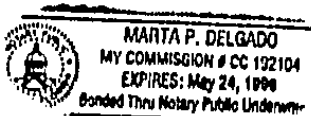
