ARTICLE I - NAME

The name of this Corporation is Preferred Treats Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The mamimum number of shares which this Corporation is authorized to have outstanding at any time is five hundred ( 500.00) shares of common stock having a par value of One (\$1.00 ) Dollar per share.

ARTICLE V - INITIAL REGISTERED






