Pursuant to the provisions of Section 607.1401 of the Florida Business Corporation Act, Launchpad, Inc. (the "Corporation"), a corporation organized and existing under the laws of the State of Florida adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:
