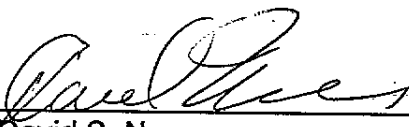

ARTICLE II

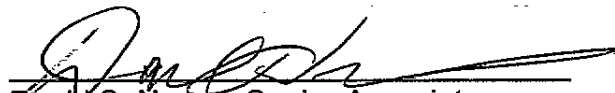
The date of Dissolution was authorized July 29, 1999.

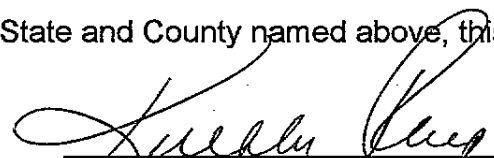
