# ARTICLE I. CORPORATE NAME

The name of this corporation is: UPS PETS, INC., where the principal office is: 10520 Branchton Church Road, Thonotosassa, FL 33592.

## ARTICLE II. NATURE OF BUSINESS AND POWERS.
