ARTICLE I - Name of corporation:

The name of this corporation is : GenX Technologies, Inc.

ARTICLE II - Duration:

This corporation shall have perpetual existence commencing on the date of this filing of those Articles with the Department of State,

ARTICLE III - Purpose:

This corporation is organized for the purpose of transacting of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes as same now exists or may hereafter be amended.

ARTICLE IV - Capital Stock:

This corporation is authorized to issue 1000 shares of One Dollar (\$ 1.00) par value common stock which shall be designated as " Common Shares".

ARTICLE V - Pre-Emptive Rights :

Every shareholder, upon the sale for cash af any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article VI - Initial Registered Office and Agent:

The street address of the initial registered office of this corporation is 10161 NW 5th St., Pembroke Pines, Fl. 33026 and the name of the initial registered agent of this corporation upon whom service of process may be had is William FARR.

Article VII - Initial Board of Directors:

This corporation shall have One Director constituting the initial Board of Director. The number of directors may be either increased or decreased from time to time by bylaws; however, there shall never be less than one Director nor more than Five. 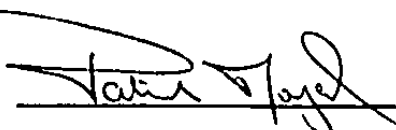

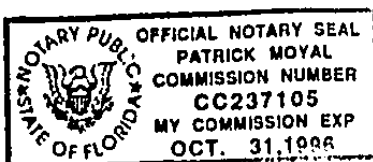
