**ARTICLES OF INCORPORATION**  
**CHRISTIAN COMMUNICATIONS NETWORKINGS, INC.**

I, the undersigned subscriber to these Articles of Incorporation, do hereby form a corporation for profit under the laws of the State of Florida, as follows:

**ARTICLE I: NAME**

The name of the corporation shall be **CHRISTIAN COMMUNICATIONS NETWORKINGS, INC.**

**ARTICLE II: PURPOSE**

The general purpose for which the corporation is organized includes the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

**ARTICLE III: CAPITALIZATION**

The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares, each share having a par value of ONE DOLLAR (\$1.00).

This corporation is to exist perpetually.

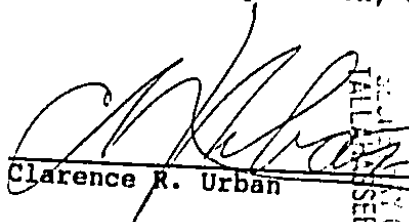
**ARTICLE VI: DIRECTORS**

The corporation is being formed, and these Articles are being subscribed to by Clarence R. Urban.

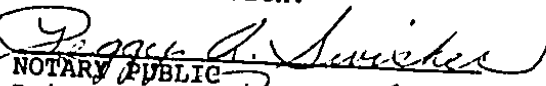
