ARTICLES OF INCORPORATION OF DIAMOND AIRE OF VENICE, INC.



ARTICLE 1. - NAME

The name of this corporation is DIAMOND AIRE OF VENICE, INC.

ARTICLE 2. - DURATION

The term of existence of the corporation is perpetual.

ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of engaging in and transacting any 1 all activities or business permitted under the laws of the United States of America and the State of Florida.

<u>ARTICLE 4, - POWERS</u>

This corporation shall have all of the powers enumerated in the Florida Business Corporation Act.

ARTICLE 5. - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock with a par value of \$1.00 per share.

ARTICLE 6. - PREEMPTIVE RIGHTS

Such preemptive rights shall apply to such shares whether such additional shares constitute a part of the shares

presently or subsequently authorized or constitute shares in the treasury of the corporation and shall be exercised in the ratio that the number of shares held by each stockholder at the time of issue bears to the total number of shares outstanding in the name of all stockholders.

ARTICLE 7. - PRINCIPAL OFFICE AND REGISTERED AGENT
