ARTICLE I - NAME

The name of this corporation is Percy's Atlantic Coast Gymnastic Inc.

ARTICLE II - MAILING ADDRESS

The mailing address for this corporation shall be 6157 Seminole Terrace, Margate, Florida 33063. The principal office of the Corporation shall be in Broward County. The Board of Directors may vote from time to time to move the mailing address and principal office to any other office in the State of Florida.

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE IV - PURPOSE

The general nature of the business to be transacted by this Corporation shall be to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V - CAPITAL STOCK

This corporation shall be authorized to have a minimum of 100 shares of stock outstanding at any one time. The shares of stock authorized shall be common stock having a par value of Ten Dollars (\$10.00) per share. The qualifications for members and the manner of their admission shall be regulated by the By-Laws which may, from time to time, be amended by the Board of Directors. The names and mailing address and number of shares of each subscriber are as follows:

ARTICLE VI - BOARD OF DIRECTORS

A. This Corporation shall have no less than one director. The number of Directors may be altered from time to time according to the By-Laws.

B. The first Board of Directors shall have the power to approve and adopt By-Laws of the Corporation until its successors are duly elected or appointed.

C. The qualifications, time and place of election, and term of office of each director shall be as provided in the By-Laws.

D. In any action or proceeding brought by or on behalf of the Corporation against a Director, if the action or proceeding results in a decision in favor of the Director, the Corporation shall reimburse the Director for all reasonable expenses incurred by him in the course of the action or proceeding.

E. The Directors shall not be liable for illegal dividends or distribution made by the Corporation, unless willful or negligent, if based on good faith reliance on representations made by officers or agents, or on records, as to the financial condition of the Corporation.

ARTICLE VII- INITIAL DIRECTORS

The name and address of the initial Board of Directors is Percy Price Jr., 6157 Seminole Terrace, Margate, Florida 33063.

ARTICLE VIII - BYLAWS

Initial By-Laws shall be adopted by the Board of Directors. The power to alter, amend or repeal the By-Laws or to adopt new By-Laws shall be vested in the Board of Directors. The By-Laws may contain any provision for the regulation and management of the affairs of the Corporation not inconsistent with the laws of the State of Florida or this Certificate of Incorporation.

ARTICLE IX - AMENDMENTS

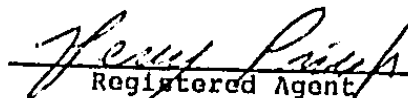
These Articles of Incorporation shall be amended upon approval by the Board of Directors.

I hereby accept this designation as registered agent, and I agree to comply with the provisions of the Florida General Corporation Law, with respect to keeping open said office.

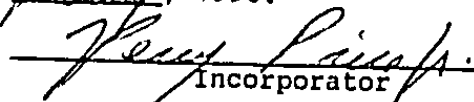
