ARTICLES OF INCORPORATION OF CASA BONITA ROTTWEILERS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, disreby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be CASA BONITA ROTTWEILERS, INC.

ARTICLE II

The corporation shall have the power to engage in any lawful activity for which corporations may by organized under the Florida Business Corporation Act.
