ARTICLE I. NAME

The general nature of the business to be transacted by this corporation

ARTICLE X. MISCELLANEOUS

This corporation shall have the right to amond or repeal any provision contained in these articles of incorporation and any right conferred upon the stockholders is subject to this provision.
