ARTICLES OF INCORPORATION

OF

MOTA METALS, INC.

The undersigned incorporators to these Articles of Incorporation, a natural persons competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be: MOTA METALS, INC.

The corporation shall have perpetual existence.

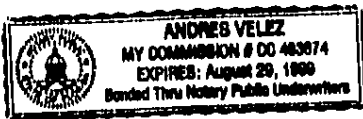

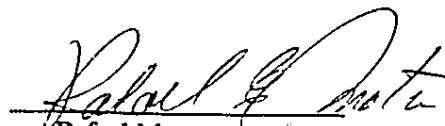
