- 1. The name of the Corporation is Direct Imaging Systems,
- 2. Article IV of the original Articles of Incorporation is deleted and the following new Article IV is substituted in lieu thereof:

### ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is increased from 1000 shares having no par value to 10,000,000 shares of common stock having a par value of \$.01 per share.
