ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is: NORTHWEST FLORIDA PAYPHONES, INC. (hereinafter referred to as the "Corporation").

ARTICLE II - DURATION

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State. ARTICLE III - PURPOSE

The Corporation is organized for the purpose of engaging in the Payphone Vending Route business, and for the purpose of transacting any or all other lawful business not inconsistent with the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK
