FIRST. The name of this Corporation is: Tammy Provence, Inc.

SECOND. Its principal/registered office in the State of Florida is to be located at 2720 McGregor Blvd., Ft. Myers, FL 33901, County of Lee. The registered agent in charge thereof is Tammy D. Provence.

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, promoted and carried on, are to engage in any lawful act or activity for which corporations may be organized under the Laws of Florida.

FOURTH. The amount of total authorized capital stock of the corporation is to be TEN THOUSAND shares of ONE CENTS (\$0.01) par value.

SEVENTH. All of the corporations issued stock, exclusive of treasury shares, shall be held of record by not more than thirty (30) persons.

EIGHTH. All of the issued stock of all classes shall be subject to the following restriction on transfer permitted by Law:

Each stockholder shall offer to the Corporation or to the other stockholders of the Corporation a thirty (30) day "first refusal" option to purchase his/her stock should he/she elect to sell said stock.
