1. The name of the corporation is: MULTIMEDIA ADVERTISING, INC.
2. An Amendment to Article I of the Articles of Incorporation has been adopted by a unanimous written consent of the shareholders of this corporation pursuant to Section 607.1002 and Section 607.1006, Florida Statutes (1997), to change the name to "USA MULTIMEDIA GROUP, INC." As amended, Article I now reads:

ARTICLE I  
NAME

The name of this corporation shall be USA Multimedia Group, Inc.

3. The above amendment to Article I of the Articles of Incorporation shall be effective immediately.
4. The date of the adoption of the amendment to Article I by the majority shareholders shall be effectively immediately.

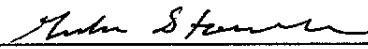
