Dear Division of Corporations Representative:

Enclosed please find the 2001 Uniform Business Report (UBR) for USA Multimedia Group, Inc., along with a check for \$150.00 payable to Department of State.

I request that the \$400.00 penalty for not filing by May 1st be waived for the following reasons:

- 1) As the President, a Director, and a 50% stockholder of the Corporation, I am responsible for the accounting and all required tax filings. The Corporation's CPA called a week prior to 05/01/01 to remind us that the UBR needed to be filed prior to 05/01/01. However, my husband and I were involved in caring for my sick father, who was in and out of the hospital and subsequently died on 05/22/01. Because of being in and out of the office with my father during the weeks leading up to 05/01/01, we overlooked the CPA's message and the timely filing of the report.
- 2) I checked back on previous years, and the annual reports were filed as follows:

<u>Report Year</u>	<u>Date Filed</u>
1998	02/02/98
1999	01/29/99
2000	04/06/00

As you can see, the Corporation has a history of timely filing the annual report, but the oversight this year was due to the illness and subsequent death of my father.

- 3) I feel that, under the circumstances, a \$400.00 late filing penalty is not justified. I will gladly pay any interest you may want to bill for the period from 05/01/01 until you receive the \$150.00 payment, but request your consideration in waiving the \$400.00 penalty.
