Enclosed please find completed Corporation Reinstatement Form and payment in the amount of \$150.00 as I've been instructed per telephone conversation with Kathy today.

I have spent much time inquiring with your department, on July 10, 2001 I had spoken with an individual named Andy who referred me to Reinstatement Division. On July 17, 2001 I spoke with Marquitta who suggested I get a reinstatement form from the web site to complete and send letter explaining why I feel the corporation should not have been revoked and therefore should not have to be reinstated. I was explained further in order too corporate the business once again I must complete the reinstatement form.

This is my explanation and reasoning behind why I feel we should not be penalized by paying the late filing fee, and/or the late fees: Prior to May of 2000 M & M Countertops, Inc. send in filing form along with payment of \$150.00. We than received a "Notice of Administrative Dissolution of Revocation" form. At that time I checked with the bank to verify that payment for initial filing had cleared, the check had cleared the bank; therefore we ignored this notification.

On July 10, 2001 when speaking with Andy he informed me the business corporation had been revoked, and as mentioned referred me to Reinstatement Division. As mentioned above I than called and spoke with Marquitta, she stated a letter was sent on 9/14/2000 to M & M Countertops, Inc. that corporation has been revoked and in order to be reinstated I must file the form with a letter stating the revocation letter sent on 9/14/00 was not received. That is the purpose of this notification.

Time is of the essence, our corporation is trying to file for workers compensation waiver that has expired, and we cannot file for workers compensation waiver until the corporation is reinstated, this is holding up all funds and payments from vendors for completed jobs and the business cannot collect the assets due them and cannot meet payroll, tax payments etc....as all assets are frozen until workers compensation waiver can be filed. Per my conversation with Kathy today, I was informed there is nothing that can be rushed or quicken filed this will take minimum 5 to 10 days, thus will be going on 3 weeks of frozen funds not released!

I am requesting at this time to please rush processing of reinstatement of corporation, reconsider the additional late filing fee and only charge the initial cost of filing as due to the revocation of status in 2000 we never received notice of filing for 2001. Your immediate attention to this matter will be most appreciated as well as reimbursing the additional \$400 paid as we feel we were not in violation of filing due to circumstances beyond our control.
