ARTICLES OF INCORPORATION
OF

The undersigned Incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the corporation shall be DAP and Associates, Inc.

ARTICLE II

Principal Office


