ARTICLES OF INCORPORATION
OF

J. L. SHARPE ENTERPRISES, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is J.L. Sharpe Enterprises, Inc., whose address is 8421 Forest Hills Drive, Suite 301, Coral Springs, FL. 33065

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

The corporation may transact any and all lawful business for which corporations may incorporate under the Florida General Corporation Act.

CAPITAL STOCK

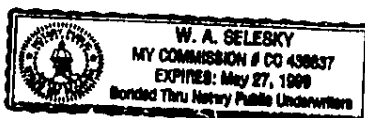
