ARTICLES OF INCORPORATION

OF

MARK DAVID PRESS, P.A.

I, Mark DAVID Press, the undersigned natural person, being licensed or otherwise legally authorized to practice the profession of law in the State of Florida, hereby associate myself with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is MARK DAVID PRESS, P.A.

ARTICLE II. DURATION

The period of the corporation's duration shall be perpetual until dissolved on a vote of the shareholder(s) as hereafter provided.

ARTICLE III. PURPOSE

The purpose of the corporation is:

- a. To engage in the practice of law as a professional law corporation and to carry on services incident thereto. The practice of law is the sole and exclusive professional service to be rendered by this corporation.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
- c. Any and all things authorized by Chapter 621, Fla. Stat.

ARTICLE IV. CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to issue is 100 shares. Such shares shall be of a single class of common stock and shall have no par value.

ARTICLE V. CAPITALIZATION

The amount of capital with which the corporation will begin to practice the profession of law is not less than \$1,000.00.

ARTICLE VI. PRINCIPAL OFFICE

The address of the corporation's principal office is: 1801 West Avenue, Miami Beach, Florida 33139. The name of the initial registered agent of the corporation, located at such office, is Mark DAVID Press.

ARTICLE VII. CORPORATE POWERS

The corporation shall have any and all rights and powers without limitation now or hereafter conferred on professional corporations by the laws of the State of Florida.

ARTICLE VIII. SUBSCRIBERS

The name and address of each person signing these Articles of Incorporation as a subscriber is: Mark DAVID Press, 1801 West Avenue, Miami Beach, Florida 33139.

ARTICLE IX. DIRECTORS

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is 1 and the name and address of the initial director is Mark DAVID Press.

The initial director shall hold office until a successor is elected and qualifies as provided in the bylaws. Thereafter the term of office of each director shall be one year and until the election and qualification of a successor. The number of directors set forth herein and constituting the initial board of directors shall be the authorized number of directors until such number is changed by a bylaw duly adopted by the shareholders.

ARTICLE X. ELECTION

The corporation has elected to operate under Section 1362 of the Internal Revenue Code.
