

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

#### **ARTICLE 1**

### NAME AND ADDRESS

Section 1.1 Name and Address. The name of the corporation is First Sports Mania, Inc., and is located Claire Lane Center, 11121-21 San Jose Blvd., Jacksonville, Florida 32257.

#### ARTICLE II

#### **DURATION**

Section 2.2 <u>Duration</u>. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by Department of State.
