ARTICLE I - NAME

The name of the corporation is: DUSON INTERNATIONAL, INC.

ARTICLE II - PURPOSES

This corporation is organized for the following purposes:

- A. To manufacture, distribute, buy, sell, import, export, and otherwise deal in and with inexpensive consumer goods made of synthetic materials, wood, and metal, including but not limited to party/gift favors, toys, novelties, models, and similar products; to develop, patent or otherwise legally protect and exploit new formulae and methods for the fabrication of these and similar products; and to manufacture, buy, well, or otherwise obtain and dispose of machinery, tools, accessories, and all other thing necessary or useful in such business.
