of

ARTICLE I

CORPORATE NAME

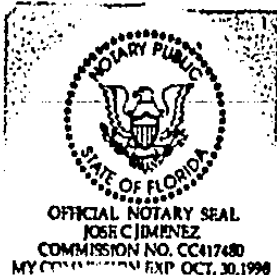
