ARTICLE I - NAME OF CORPORATION

The name of this Corporation is: VetSound Imaging, Inc..

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is allowed and authorized to issue and have outstanding at any one time is 500 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV - TERM OF EXISTENCE

This Corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation.

ARTICLE V - REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The Registered Agent and the street address of the initial registered office of this Corporation in the State of Florida shall be: Kevin W. Snider, 2224 Tipperary Court, Orlando, FL 32812, and the principal office address shall be the same.

The Board of Directors, from time to time, may move the registered office to any other address in the State of Florida.

ARTICLE VI - BOARD OF DIRECTORS

This Corporation shall have three (3) directors initially. The number of directors may be increased or diminished from time to time by by-laws adopted by the stockholders but shall never be less than one (1).

ARTICLE VII - INITIAL DIRECTORS

The names of the initial directors of this Corporation and their street addresses are: Kevin W. Snider, 2224 Tipperary Court, Orlando, FL 32812; Larry O. Bernecker, 2508 Crestview Drive, Appleton, WI 54915; John K. Snider, 5359 Emerald Isle Drive, Orlando, FL 32812. The persons named as initial directors shall hold office for the first year of existence of this corporation or until their successors are elected or appointed and have qualified, whichever occurs first.

ARTICLE VIII - PERSON SIGNING THESE ARTICLES

The name and street address of the person signing these Articles of Incorporation is: Kevin W. Snider, 2224 Tipperary Court, Orlando, FL 32812 as Incorporator and Kevin W. Snider, 2224 Tipperary Court, Orlando, FL 32812 as initial registered agent.

ARTICLE IX - AMENDMENT

These Articles of Incorporation may be amended in a manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the

stockholders and approved at a stockholders meeting by at least a majority of the stockholders entitled to vote, unless all the directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

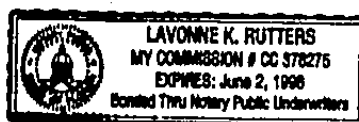
