

ARTICLES OF INCORPORATION

ARTICLE 1 - NAME OF CORPORATION

The name of this Corporation is: VetSound Imaging, Inc..

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK
