ARTICLES OF INCORPORATION of <u>K. M. C. PROPERTY, INC.</u>

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE 1 - Name. The name of the corporation is K. M. C. PROPERTY, INC.

<u>ARTICLE II - Purpose</u>. Corporate Purpose and Powers. This corporation is initially organized for the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607.011 of the Florida Statutes. This corporation shall have all corporate powers enumerated in said Chapter 607.011.

<u>ARTICLE III - Capital Stock</u> The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1000) shares of common stock. Such shares shall be of a single class, and shall have a par value of one dollar (\$1.00) per share. Stock shall be issued under Section 1244 of the Internal Revenue Code.

<u>ARTICLE IV. Initial Capital</u>. The amount of capital with which the corporation will begin business shall not be less than \$500.00.

ARTICLE V. Duration. The corporation shall have perpetual existence.

<u>ARTICLE VI - Principal Office</u> The street address of the principal office of this corporation in this state is 420 East Pine Avenue, Crestview, Florida 32539, and the mailing address is P.O. Box 727, Crestview, Florida 32536.

<u>ARTICLE VII - Initial Registered Office and Agent</u>. The street address of the initial registered office of this corporation in this state is 420 East Pine Avenue, Crestview, FL 32539, and the mailing address is P.O. Box 727, Crestview, FL 32536. The initial registered agent at that address shall be Chris Cadenhead.

<u>ARTICLE VIII - Management by Shareholders</u>. The corporation, pursuant to the authority vested in Section 607.111, F.S. shall be managed by its stockholders rather than a board of of directors, and the stockholders shall elect the officers. The initial stockholders in the corporation and who shall initially manage the business are:

<u>ARTICLE X. By-laws</u>. The power to adopt, alter, amend or repeal the by-laws of this corporation shall be vested in the shareholders.

<u>ARTICLE XI - Amendment</u>. These Articles may be amended in the manner provided by law. Every amendment shall be approved by vote of 51% of the stock entitled to vote thereon.

<u>ARTICLE XII - Dissolution.</u> The corporation may be dissolved at any time by unanimous written consent of the shareholders, or on the affirmative vote of the holders of at least two-thirds of the outstanding shares of the corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him.
