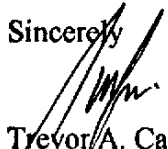
I write to request that you consider an abatement of the penalty for reinstating Micro Services Industries Inc.

We are a new and very small company. We contracted the services of an accountant, Mr. Guillermo Liera Donadio, to take care of all corporate matters including sales tax, corporate returns and others. We faithfully pay Mr. Donadio, **quarterly in advance**, for these services. We had no idea that he was negligent in these duties. When we confronted him about the matter all he could say is **"I don,t understant what happened, I sent in everything"**.

Micro Services has no intention of being delinquent. We cannot afford to be. At the time of writing this letter, even our sales tax has been canceled. We want to comply and in this regard we have engaged the services of new accountants. They are Kruzel, Brass and Associates, certified public accountants (954-474-4100).
