## ARTICLES OF INCORPORATION

OF

## ANNE PETERSON, INC.

## Article I - Name

The name of this corporation is ANNE PETERSON, INC.

## Article II - Duration

This corporation shall exist perpetually, commencing on the date of filing.

## Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

## Article IV - Capital Stock

This corporation is authorized to issue 6,000 shares of \$1.00 par value common stock.
