

ARTICLES OF INCORPORATION

OF

SEVILLE DINER, INCORPORATED



The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this corporation is SEVILLE DINER, INCORPORATED, and its principal office is located at 1901 E. Lee Street, Pensacola, Escambia County, Florida 32503.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgement of these Articles of Incorporation.

ARTICLE III

PURPOSE

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States or the State of Florida.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue one hundred thousand (100,000) shares of \$.10 par value common stock, all of one class and series.
