**ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the provisions of Chapters 607 and 621 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation is LAURIE LLOYD GORDON, P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III - NATURE OF BUSINESS

The general nature of business to be transacted by this corporation is:

1. To engage in and carry out the practice of law; to carry on said practice only through officers, employees and agents who are duly licensed and authorized to render legal services in the state of Florida.

2. In general to carry on any business in connection with said law practice and incident thereto not forbidden by Chapters 607 and 621 of the Florida Statutes, and with all the powers conferred upon corporations by the laws of the State of Florida, and at all times comply with the provisions of Chapters 607 and 621 of the Florida Statutes, as presently enacted and as may be hereafter amended or superseded by any other Statute.

ARTICLE IV - CAPITAL STOCK

1. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of One Dollar (\$1.00) per share.

2. No stock may be issued to any individual not licensed to practice law in the State of Florida. No stockholder may enter into voting trust or any other type agreement vesting another person with authority to exercise power to vote the stock of this corporation.

ARTICLE V - INITIAL CAPITAL

The amount of capital with which this corporation will begin business is One Thousand Dollars (\$1,000.00).

ARTICLE VI - ADDRESS

The initial post office address of the principal office of this corporation in the State of Florida is Post Office Box 561310, Orlando, Florida 32806. The stockholders may from time to time move the principal office to any other address in Florida.

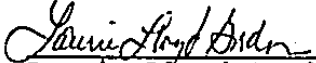
ARTICLE X - AMENDMENT

The name and address of the sole incorporator of the corporation is: Laurie Lloyd Gordon, 910 Lancaster Drive, Orlando, Florida 32806.

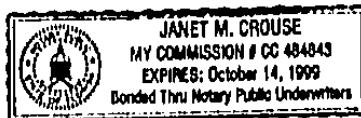
