The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

Name

The name of the corporation is AUTOMATED BUSINESS MACHINES OF TAMPA, INC.

ARTICLE II.

Address

The principal address of the corporation shall be 12608 N. Nebraska Avenue, Tampa, FL 33612

ARTICLE III.

Duration

The duration of the corporation is perpetual.

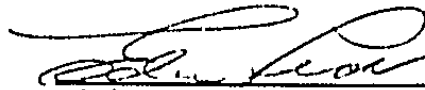
