ARTICLES OF INCORPORATION
OF
DP TRADING CO.

I, the undersigned incorporator, being of legal age, hereby file for the creation of a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights, and immunities of corporations for profit.

The name of this Corporation shall be:
DP TRADING CO.

Its business shall be carried on at Miami, Florida, and at such other point or places in the State of Florida, and in the United States and foreign countries as may from time to time be authorized by the Board of Directors.

PURPOSE: The purposes of the Corporation is to engage in any activities or businesses permitted under the laws of the United States and the State of Florida.

Duration: This Corporation shall have perpetual existence, unless sooner dissolved by operation of law.

Capital Stock: The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is Ten Thousand (10,000) shares of common stock having no par value.

Preemptive Rights: Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

Initial Board of Directors: This corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time by an amendment of the

bylaws of the corporation in the manner provided by law, but shall never be less than one (1).

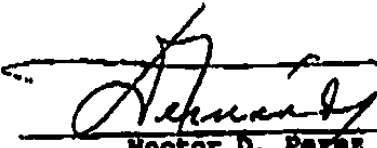
