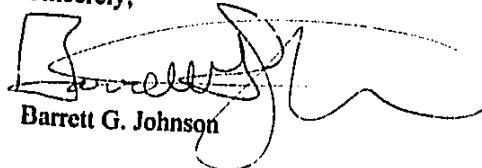

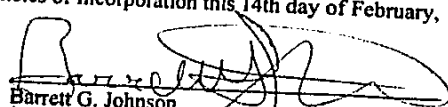
Article VII

The corporation shall exist perpetually or until terminated by law. International Health and Medical Services, Inc. exists for the purpose of engaging in any lawful business.

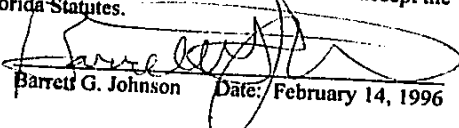
Article VIII
